Mayor Clemetson regarding Hunter North Land acquired land next to the well, Company asked if the city would like to hire them to clean up the area for a fee, some council mentioned that area is also in county right of way, and that our city and the City Redfield would or could work together on cleaning up the area. Ed Leedom was contacted for a possible contract with the city for Code Enforcement Officer Position Agreement, to come to a council meeting to discuss his process.

Clerk Heckman discussed Forty-Nine (49) delinquencies were mailed out, Twenty-two (22) 24 Hr notices hung. Two (2) shutoffs. The city renewed CD's, due to the increased interest rates.

Boards & Committees The Dallas County Sheriff's Office provided handouts. Library provided a handout for their November meeting, the December meeting their skip month. The City Clerk and Librarian did receive the Carver Trust Grant for the library to help with the Facade. The Community House - provided Roundhouse financial handouts.

Reports City Department Public Works provided handouts, as well as a proposed construction update for the area around the lagoon, if they could put up a fence and lock to secure property, maintenance access gate, on lot line, this will be brought up at a future meeting. Fire & Rescue handouts.

Old Business The cities of Dexter and Redfield Revised 28E agreement between the two cities. Morehouse made a motion to approve Resolution 2024 - 04, seconded by Cope. All aye Morehouse, Warrior, England, Cope.

1023 Polk is now the property of the City of Dexter, Liability Insurance is on the property. Eviction is imminent.

The County Auditor will send the notice to property owners of the proposed tax levy for the city by March 25th for our tax rate of \$16.64. At the March 11th council meeting the city will vote to hold a public hearing for April 8th at 6:45 p.m. to approve the tax rate.

Daniel Frank had asked to speak about a water leak affecting the cost of his water bill. He did not attend the meeting so the council did not address the issue.

Agreement with Dallas County Sheriff tabled until March 11th, 2024, Mayor Clemetson and CC Member Morehouse, Dallas Co., re-writing the the contract and payment for the year will be lowered

CDBG façade grant Draw 4 in the amount of \$14,072, motion was made Warrior, seconded by England. All aye Morehouse, Warrior, England, Cope.
